Is the present mode of teaching aqequate and effective?




Diagram-1: Shows the perception of parents about the present mode of teaching

Significance: Mode of teaching plays a vital role in terms of academic achievement; acquisition of knowledge about content and concept development. Adequate and effective mode of teaching reduces the academic deficiency of a learner in a class room situation. Though parents are not directly involved with classroom teaching, but they get information from their ward about the mode of teaching deliver a teacher in classroom situation. So, parents of pupils also bear the perception about mode of teaching in the classroom interaction indirectly. From perceptional point of view, it can be said that majority parents (86.17%) of K.D College are highly satisfied in the present mode of adequate and affective teaching.

Is the ward satisfied with the course content?




Diagram-2: Shows perception of parents about course content.

Is the syllabus of each subject completed duty?




Diagram-3: Shows the Perception of parents about completion of syllabus in each subject.

Is the time table convenient enough to ward in attending his/her classes?




Diagram-4: Shows perception of parents about time table convenient enough to their ward in attending his/her classes.

Do you have any complain from your ward regarding ancillary services like office and library services?




Diagram-5: Shows the perception of parent about complaints from their ward regarding ancillary services like office and library services.

Is your ward satisfied with the canteen services?




Diagram-6: Shows the perception of parent about satisfaction of their ward with canteen service.

Do you encourage your ward in attending classes regularly?




Diagram-7: Shows whether parents encourage their ward in attending classes regularly.

Do you encourage your ward in attending classes regularly?




Diagram-8: Shows encourage their ward in participating in various types of co curricular activities organized by the college/affiliating university.
